3. AND WHEREAS, the institution Govt. Degree College, Nainidanda, Patotiya, Dhumakot, Pauri Garhwal-226277, Uttrakhand has by affidavit consented to come under New Regulations and has sought for one basic unit in B.Ed.

4. Now therefore, in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Northern Regional Committee, NCTE hereby grants recognition to Govt. Degree College, Nainidanda, Patotiya, Dhumakot, Pauri Garhwal-226277, Uttrakhand for conducting B.Ed. programme of two years duration with an annual intake of 50 for one basic units of 50 students from the academic session 2015-2016.



- Name of faculty members who left or joined during the last quarter.
- Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- Fee charged from students.
- Available infrastructural facilities.
- Facilities added during the last quarter.
- Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- The affidavit with enclosure submitted along with application.

- (j) The institution shall be free to post additional relevant information, if it so desires.
(k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
